Agfest 2009

The 18th annual Agfest is scheduled for the weekend of June 6th and 7th. The Antique Machinery and Agricultural Festival is a celebration of the history of agriculture in the region, featuring two packed days of music, demonstrations and activities for kids and adults.

This year's displays include touch and go planes, hit & miss engines and John Scott's working portable saw mill. The weekend will also be filled with musical performances by The Shovel Back Band, Music Magic by Kevin Hotaling and Squeeze Play with Steve Schwebler.

It's always a great weekend for kids, and this year is no exception. A bouncy bounce will be set up and the children's

tent will be set up with painting, coloring, face painting, a sandbox filled with corn and a tractor maze.

Prizes will be given out for the pie eating and pudding drop contests and the Agfest Idol contest should be a highlight of the weekend.

Plenty of food will be available, from the barbecue and breakfast prepared by Cornell Hook and Ladder Co. and the Ladies Auxiliary. Frozen desserts and lemonade by Guido will also be sold.

Bids for the Silent Auction benefitting the festival will be taken both days under the big tent. The auction will feature merchandise and gift certificates donated by local businesses.

New Baltimore Filmmaker Jonathan Donald Explores History of Greene County

New Baltimore filmmaker Jonathan Donald has spent the last three years delving into Greene County's history and he has come up with some surprising results.

"Greene County has been the source of more people and events of state, national and even international significance than one would ever expect," he says. The results of his investigations have been put together into a documentary, "Greene County, USA: A Local History of National Importance," which will air on PBS this September.

Donald was originally introduced to the idea twenty years ago, when the Greene County Historical Society asked him to take on the project. Though that wasn't the right time, Donald thought about it over the years. "Then I realized that Raymond Beecher was getting on in years. He's done so much for the county that I thought this was something I could do to honor his work."

Greene County has been the home to many entrepreneurs, ideas and inventions, Donald says. Levi Hill, for example, has been acknowledged by the Smithsonian as having invented the first color photo process in the 1840's. "Hill was a great threat to the daguerreotypists in New York City, who conspired to obscure his fame."

The Hudson River School of Art was the first native art school and is credited with helping to launch American tourism as people became aware of the beauty of the Catskill Mountains and flocked to the great hotels and resorts which were built in the mountains.

Donald's film incorporates old graphics, documents, maps and reenactments to capture the history of the county and its people. The reenactments include the kidnapping of a Whig judge by Tories and a tavern scene portraying the Dutch celebrating William of Orange's invasion of England.

"I think Greene County is special," Donald says. I've discovered more significant history of national importance in this quiet little place."

A local premiere of "Greene County USA" is scheduled for September 12th at the Catskill Community Theater in Catskill.

News and Issues

Town Board Report

The Town Board has met in regular monthly meetings held on January 5th, February 9th and March 9th. Public Hearings were held on January 5th for purposes of hearing public comment on Local Law 1 of 2009 (setting sewer use rates for 2009) and Local Law 2 of 2009 (making technical amendments to the Town's Zoning Ordinance), and on January 26th to hear public comment on Local Law 3 of 2009 (establishing a new schedule of property tax exemptions for senior citizens and persons with disabilities).

Here is a summary of the actions taken at these meetings:

January 5th

- •The Town Board adopted Local Law 1 of 2009, establishing sewer use fees for New Baltimore Sewer District No. 1 for 2009. The sewer use fees were virtually the same as those in effect for 2008.
- •The Town Board adopted Local Law 2 of 2009, enacting revisions to the Town's Zoning Ordinance and Zoning Map to make minor technical revisions to the zoning changes adopted in November, 2008, pursuant to Local Law 4 of 2008.
- The Town Board authorized the transfer of \$15,000 from the Highway Fund to the Capital Reserve Fund for Highway Equipment in accordance with the 2009 Town Budget.
- The Town Board, following a bid opening held earlier, accepted a bid in the amount of \$18,854 from Crossroads Ford & Mercury to sell the Town a 2006 Ford F350 Truck for use by the Town Highway Department, and authorized the expenditure of \$18,854 from the Capital Reserve Fund for Highway Equipment as the source of funds for the purchase of this truck.
- •The Town Board authorized attendance at the annual meeting of the Association of Towns of the State of New York.

•The Town Board authorized a renewal of the Special Use Permit for JB Car Services for the processing of junk vehicles.

February 9th

- •The Town Board adopted Local Law 3 of 2009, establishing a new schedule of real property tax exemptions for persons sixty-five years of age or over and persons with disabilities and limited incomes. The maximum income for the highest (50%) exemption was increased from \$18,500 to \$19,500, and the maximum income for any exemption was increased from \$26,900 to \$27,900.
- •The Town Board established the Town of New Baltimore <u>Citizens' Bicentennial Celebration Committee</u> to undertake the planning of the celebration of the 200th anniversary of the establishment of the Town of New Baltimore to be held in 2011. Town resident Joyce Schoenig was appointed as the Chair of this committee.
- •The Town Board authorized Supervisor Louis to execute the 2009 Contract for ambulance service to be provided by the Ravena Rescue Squad to New Baltimore Ambulance District No. 1 (eastern part of the Town), for a total cost of \$18,000.
- •The Town Board adopted Resolutions in opposition to the following 2009-10 State Budget proposals from the Governor:
- Opposing the proposal to restructure funding for youth development and detention programs into block grant funding
- Opposing the proposal to freeze property tax payments made by the State of New York on state owned land.
 The Town Board adopted amendments to the 2008 Town Budget to allow for the 2008 books to be closed.

March 9th

•Following a public bid opening, The Town Board authorized the sale of the following used equipment:

- 1993 Ford F-350 Dump and Plow for the amount of \$4,501
- Bolens 18HP Tractor with Front End Loader for the amount of \$2,075
 The Town Board authorized the expenditure of \$1,250 for the Food and Fun for Seniors Program, which is open to all town residents, being held each month at the New Baltimore Reformed Church. This program is being funded from an appropriation made in the 2009 Town Budget for senior citizen programs.
- •The Town Board authorized the expenditure of \$500 to the New Baltimore Farmers' Market to assist the Farmers' Market for its 2009 season.
- •The Town Board authorized the expenditure of \$100 to the Town of New Baltimore Citizens' Bicentennial Celebration Committee to defray the cost of postage and office supplies as they begin operation to celebrate the Town's 200th birthday in 2011.
- •Supervisor Louis briefed the Town Board and the public regarding the funding opportunities that may be available to the Town from the Federal Stimulus Program. Supervisor Louis reported that the Town would not be eligible for funding for drinking water projects, as the current hamlet water project is not shovel ready since voters had failed to give approval to a cost increase in 2006. The Town will also not be eligible for highway funding since Stimulus funds can only be used for roads that are part of the Federal Highway Aid system (local roads are not classified as being a part of this system). The Town may be eligible for funding for energy efficiency and alternative energy projects; these details are still being worked out at the federal and state level and the Town will identify potential energy efficiency and alternative energy projects involving town buildings and facilities to be ready to seek stimulus funds as they become available.

Planning Board Report January

February's report to the Town Board outlined the Planning Board's meeting on January 9, 2009, where the following business was transacted:

Held discussion with Paul Schiller regarding status of his Site Plan and the completion of the log home sales center.

The Planning Board also held a Work Meeting on January 22, 2009, for the purpose of familiarizing the Board with the Conservation Subdivision portion of revised zoning.

February

The Planning Board met on February 12, 2009, and continued discussion with Paul Schiller regarding status of his Site Plan for the log home sales center; and approved a one-year extension of Site Plan for Jyoti SAI Hospitality, LLC, for Holiday Inn Express.

Zoning Board of Appeals Report

The Zoning Board of Appeals did not meet in February or March as there were no applications to come before the Board.

Building and Code Enforcement Reports

Senior Code Enforcement Officer/ Building Inspector John Cashin reported for January: New Building Permit Applications Received - 1; Car Restoration Permit Application - 1; Pool Permit Applications – 1; Building Permits Issued -1; Building Inspections -20; Certificates of Occupancy granted -2; Certificates of Compliance Granted - 3; Junk Vehicle Complaints – 2; Court Appearances - 1; Zoning Violation Investigations - 2; Code Violation Investigations - 8: Commercial Site Fire Inspections – 1; for total January application fees - \$ 210.00; and Total Fees for Year to Date:\$210.00.

No report for February was given at March's Town Board meeting.

Assessor Report

In February Assessor Gordon Bennett reported applications are continuing to come in for STAR Enhanced Exemption renewals. Property owners are returning their completed forms for aged and other exemption renewals; a good percentage have returned their forms to the office to date and follow-up contact is being made for any incomplete applications. Town Data Collector, Don Daoust is presently in the field for annual review of the 2009 Roll. The open building permits have been prioritized, enabling Don to be more proficient in his review time.

In March 2009 Report to the Board, Gordon Bennett reported that Field review has been prioritized and the Annual Review is in Progress. Also, assessment change notices will be sent to property owners whose assessments have changed due to construction and/or new data inventory. The Valuation Tentative Roll Schedule for 2009 has been published as follows: March 10th and 17th 9:00am-1:00pm; May 5th and 12th 9:00am-1:00pm. Grievance Day is set for May 26th and the times available will be 12:00n-3:00 pm and 7:00-9:00 pm: kindly note the Assessor's office will be closed on March 31.

Bicentennial Committee Meets

On February 9, 2009, the Town Board passed a resolution establishing the New Baltimore Citizens' Bicentennial Celebration Committee and charged the committee with the task of undertaking the planning of the 2011 celebration of the 200th anniversary of the establishment of the Town of New Baltimore by the State Legislature in its 34th Session on March 15, 1811. New Balti-

more citizen Joyce Schoenig was appointed Chair of the Committee. Joyce announced the first meeting of the Committee will be held on February 21, 2009 and invited all residents interested to attend.

On February 21, 2009, the first meeting was held in the home of Jeff and Joyce Schoenig. Attending were Cliff Baldwin, Town Historian Clesson Bush, Rev. Susan Kerr, Susan McCuen, Arlene McKeon, Betty Nickles, John Nickles, Chris Norris, Joyce Schoenig, and Jeff Schoenig. The Committee name of the New Baltimore Bicentennial Committee (NBBC) was chosen as well as a "catch phrase" of "200 Years of Community." Discussions were held on design of a web page attached to the town website; coordination with all community organizations, families, churches, businesses, etc., to contribute histories; and fundraising. It was proposed that local artist talents be used to develop a logo for the celebration. Further discussions included videotaping town residents with ties to the past, present and future; the importance of collecting stories; and several ideas for multiple events to be held throughout the year of 2011 in celebration.



Notes from the Agriculture Committee

The New Baltimore Agricultural Committee has been meeting monthly during 2009. The Agricultural Committee has been focused on both the historical significance of farming in New Baltimore and the potential for a future of flourishing farms in our town.

Members of the Ag Committee visited the Town of Durham, where a group of citizens are working with an organization called the Glynwood Center to create a business plan for promotion of agriculture and forest products. Durham is focusing on grassfed meat as an agricultural product.

The Glynwood Center is an organization that assists communities in assessing their assets and planning for a successful future in agricultural production, while maintaining the integrity of the natural landscape. In February, a

representative of Glynwood Center attended a New Baltimore Ag Committee meeting to discuss the possibility of assisting New Baltimore in formulating a strategy for enhancing and supporting agricultural enterprises in the Town. After meeting with the Glynwood Center and discussing potential for funding such a project, the Ag Committee decided to continue to work on its own to create successful efforts such as the Farmers' Market in pursuit of economic viability for small farms in the area.

During the March meeting, the Committee agreed that it would be helpful to have a map of the Town that highlights natural resources and working farms. In addition to requesting to use maps created for the revision of the comprehensive plan, the Ag Committee will request that Greene County Soil and Water Conservation District create a map of the Town using GIS technol-

ogy. The map will show roads, waterways, forested land and open fields. The map will have many uses, including identifying active and fallow farmland, and forming the basis for a resource guide of farming related products.

The members of the Ag Committee recognize that remembering the past of farming in our community is an important aspect of moving forward. There are many stories of our farming past that have great value and that should be preserved for future generations. The Ag Committee will be hosting a Farm History Gathering at the Town Hall on Sunday, April 19 at 2 pm. At the gathering, Edger Van Slyke and Pauline Van Etten will recall working in the dairy business during its heyday. Everyone is invited to attend to share stories that they remember about the good old days of dairying. The event will be recorded on digital audio for posterity.


Medway Methodist Episcopal Church (west of Medway Congregational Church – torn down ca. 1955)


Safety Regulations

New Pastor at Medway Church

The Board of Trustees of Medway Congregational Christian Church, Rt. 26, Climax, has announced the selection of a new pastor. He is Matthew E. Marlow, 25, a recent graduate of Gordon-Conwell Theological Seminary in South Hamilton, Massachusetts, where he received a Master of Divinity last December.

Medway, an historic church dating from the 1790s, participated in the Underground Railroad, as a secret relay station for black slaves escaping from the southern states. Sunday church service is at 10:00 a.m.

When asked what new initiatives he may have planned for the church, Marlow answered: "The board and I are agreed that we will have more community outreach dinners, and, in time, we may even do door-to-door home visits, to invite people to worship with us."
