**OPENING OF REGULAR MEETING**

Supervisor Dellisanti opened the meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Deputy Supervisor Ruso, Councilwoman VanEtten, Town Clerk Finke, Tax Collector Jordan and 4 members of the public who signed the attendance book.

Absent: Councilwoman Benway, Councilman Norris, and Highway Superintendent Jordan

**Supervisor Dellisanti** began thank you all for coming; I hope you all had a healthy Merry Christmas. Our first order of business tonight is Mary Beth from Delaware Engineering to give us an update and some good news.

**Mary Beth Bianconi** agreed this is good news and frankly a lot of years from everybody. Our Wastewater Treatment Plant continues to age just like everything else. We've been taking for some time about necessary upgrades to extend its useful life. And as we've talked about over the years, our issue is more that no matter what, there's certain improvements we have to make, we just don't have a lot of people sharing the cost. That makes the costs very high. We've been chasing now for some time now low-cost financing for this project and up until this year, we've been really challenged. How you get low-cost financing is you compete on an environmental basis and you compete on an economic need basis and we have been hovering right around being qualified for low-cost financing, but we've never really gotten over the bar until now and how we got over the bar is a couple of things. One is some folks here spent some time a little over a year ago preparing an Income Survey. You may remember Candace Balmer from RCAP Solutions was here, we had volunteers, people did some really, really hard work and that benefitted us tremendously. While in actual fact it didn't drop our income tremendously, that \$55,000 MHI combined with a program change that is brand new for this year, it says that if your Median Household Income based on either the 2013 Census or an Income Survey that qualifies, which yours did, is less than \$58,003, you qualify for Hardship financing which is 0% interest. In addition, because our income is below that \$58,003, we got 10 extra need points which put us over the bar. We are literally one project over the bar. Yours is the project that is at the bar. The project that is below the bar is also my project. They are not very happy. I'm with them tomorrow. What I handed out, basically what I'm saying is this is our opportunity to advance this project. We are never going to get better than 0% financing; it's not going to happen. The likelihood of us qualifying for a grant is unfortunately somewhat low. You'll note if you can't sleep tonight and scotch doesn't do it for you, if you read through all this nice stuff I gave you which are excerpts from the program documentation, you'll see that in order to qualify for a grant, your median family poverty rate has to be greater than or equal to the statewide poverty rate which is 11.7 %. So that's families living at or below poverty in your area. You are at 4.2% which is good, people here have jobs, but it also means that you don't qualify for a grant. So I trust that you want to move forward with the project at this time. The way the program works is this is a one-time deal, we qualify, the Supervisor got a nice, very brief letter saying congratulations you qualified, please provide us with a bunch of stuff. If we don't do this, we go back into competition for next year and there's no guarantee that there will be the same level of funding, you don't know who you are competing against, you don't know whether will be, you are literally at the line and I gave you a copy of you being at the line here, there you are at the line. So my suggestion is we move forward with this project at this time. So what does that mean? The other part of your packet, which is the second paper clipped thing, which is a resolution, you've done this a million times before. This is a SEQRA resolution stating that you want to act as Lead Agency for your Wastewater Treatment Plant project. That's the only thing we need to do tonight is adopt a resolution that says we want to act as Lead Agency for our project. Folks in my office will do a circulation among the involved agencies which in this case is very few. DEC primarily, you don't need a lot of approvals or permissions or permits from anybody. You have an existing plant, all of the work you may recall from our little picture is being done on the plant site proper in areas that were previously disturbed so we don't need a lot of approvals or permits from anybody; pretty straightforward project. What we would do is we would adopt that resolution tonight; we'll do a circulation for Lead Agency. At your February Board meeting we will declare ourselves Lead Agency because trust me nobody will want to be Lead Agency for your Sewer project; we have to adopt a Bond resolution which I will coordinate with Chris Chale who I am assuming she's still your Bond Counsel. We also have to do something that's called an increase and improvement. We did that before, we did that for the Mill Street project. It's a resolution that says we're a Town, we have a Sewer Plant, we spend a certain amount of money on it today, we intend to spend more money on it and you have to notify the public that you're intending to do that. So it's an increase and improvement resolution. I'll coordinate that with her. We adopt a bond resolution; we notice that resolution, we fill out some forms which we'll bother Barbara about, some paperwork that we need from

her. We send all of these goodies in before March 1<sup>st</sup>. A couple months later, usually because they get hundreds of these on March 1<sup>st</sup>, you'll get another letter which looks shockingly like the first one, but this list will be different. It will say thank you for sending us a bunch of stuff, now please send us more things and there will be a list of more things to send.

**Supervisor Dellisanti** inquired you are going to send the stuff in that's needed here.

**Mary Beth Bianconi** confirmed we will do that, yes. One of the things that we need to do and I gave you a check list as well towards the end of that first packet. The checklist is kind of long, but all we're doing at this time is the first page of the checklist. One of the things that we have to submit is an Engineering Agreement so we will come back to your next Board Meeting with an Engineering Agreement. You need something in the works to show that you are intending to move forward with this project. So we will do that. After you get the second letter back, we will compile all the goodies – usually that takes around a month to do or so, we're usually into April timeframe by then. You will eventually be notified that you have a complete application. The State has a multi-tiered process as you might imagine from the State. There is a loan committee that meets once a week. If we get everything done, we go to the loan committee. After the loan committee says yes, everything is all square, it goes to the EFC Board which is a consent agenda that happens once a month. It goes to something called the Public Authorities Control Board, also a consent agenda that also happens once a month. That process is normally about three months. Sometimes depending on the schedule, you get it all to happen in two, it all depends on when the meetings fall. Your objective will be to close on this financing and have funds available before September 30 of this upcoming year. And here we sit, it's not even January 1 and I am already talking about September. That's going to be our timeframe. We will be closing probably sometime into September because that nice Public Authorities Control Board does not meet in August and you need their approval. So it either happens in July or it happens in September, usually September. So that's our overall process; once that's all done, a couple other things. So then we will have access to what is called a STIFF, its Short Term Interest Free Financing. So that is our funding that allows us to go forward with engineering and construction at no cost to you; you're using someone else's money and not paying interest on it which is a pretty good deal. You get through construction and at the end you know all of your costs, you will close on long-term financing and that will be your 30 years at 0% interest. The Mill Street Pump Station, you may remember we did a project there because we couldn't wait for all the rest of this to happen. That was about a \$300,000 project. We took out a BAN, we've been paying on that BAN, we constructed that BAN so that it could be rolled into this financing. So that is something that I will talk to Chris about, she will know all the ins and outs, the mechanisms of how that happens, but that was our intent was that it would become a long-term borrowing since there's no interest, it's certainly a good thing to do. One thing I have to address with her is timing, we did that as a statutory installment bond, you're allowed to hang onto it for five years, so we have to figure out how we sequence it, but I will talk to her about that. Overall you would have funds available in the fall, design and approvals would happen through the fall and winter of '16 into '17, we go out to bid in '17, construction in '17, done towards the end of '17 or early '18, it's a fairly straightforward project. The one thing that we will have to do eventually not immediately, but you may remember we had a couple of different options, we had different opportunities to take in this project. We could make use of a couple of different kinds of disinfection systems that had ways and balances in terms of costs and operational issues and those kinds of things and we could also for very, very, very little additional cost expand the plant, make it a little bit bigger certainly large enough for anything you would ever envision doing in the community and the cost was very, very inexpensive to do that. So we'll have to make those decisions as we go down the road, you don't have to do anything about them right now. You may remember the engineering report had a little bit of a Chinese menu in it. We did that so that when we got to this point any of those options would be eligible for financing so you didn't have to pick at the time, but we will have to choose and we'll go back over what they all mean cost-wise at that time. That is pretty much it, this is very, very good news. As you know we have been hanging out. I didn't realize, but it's been actually a long time that we've been here. I lose track. It's been a long time that we've been working on this. You may recall we got a grant to do the engineering report which was also critical to this; you couldn't get to this juncture if you didn't have an engineering report. So far it's been a really good project. I think this is our opportunity to do this as low a cost for the users as we possibly can. The other thing for those of you who are watchers of the financial markets, you know that our best friend Janet Yellen increased the interest rates a little bit. It's going to be awhile before that rolls forward into things that we see in our world, but it will happen. We can guarantee ourselves 0% interest financing. So that's my recommendation that we move forward. Tonight we would adopt the

Resolution for Lead Agency which you want to be Lead Agency for your own project. We'll conduct the circulation out of our office, make it simple, get you all the records that you need, and then Lindsay in my office, she's been here a couple different times, she will coordinate with Barbara to gather all the information that is necessary for the application.

**Supervisor Dellisanti** observed that's excellent. Lou, do you have any questions on this. Are you happy?

Louis Betke replied yes, very much so. I see that Plant every day; I know what's going on. I'm very excited.

**Ellie Alfeld** said one question Mary Beth. You said the Lead Agency, but you are going to wait until February?

**Mary Beth Bianconi** explained you have to. Lead Agency, the way the statute reads is you have to give the other involved agencies 30 days. We're going to actually end up probably being a few days short of 30 days, but it's going to be fine. There's kind of a notice process for projects like this. So Lead Agency is simply the agency that conducts the environmental review and they're supposed to be conducted the same regardless of who Lead Agency is, but with this program we have to conduct this type because this program starts with federal dollars. We fortunately do not have to comply with federal requirements for this project which is single audits which are \$10,000 annually. We don't have to do all that, but the State takes care of it for us, but in return, we have to jump through certain other hoops. This is one of them.

**Supervisor Dellisanti** asked for any questions.

**Mary Beth Bianconi** continued by the way, all the costs, cost got us, Bond Counsel, all that is eligible costs under the program. So the way that it works is you will accumulate those costs and when you close, you'll be able to go back and say I spent x dollars of eligible costs, write me a check and that's actually a direct deposit. You get the money back on a going forward basis.

**Councilman Ruso** pointed out the existing Bond for the Mill Street Project, our payment is due next fall. It doesn't seem as though this would be able to be rolled into this project in time for that next payment. Am I right on that?

**Mary Beth Bianconi** answered probably not because the roll would happen at long term closing which would be 2018 probably. The way that it works is we're going to get bridge financing so like if you are building a house, you go to a bank and you say I don't have the house yet, but I want you to give me the money to build the house so that I can collateralize the loan with the house and then I'll sign a 30 year mortgage using the home as the collateral. So this short-term financing you get, this STIFF financing, is that bridge loan. You spend that money on project costs. When you get finished you say I now have done the project, I know what my costs were, now I want to go forward. I believe the way it is going to work with the BAN is that whatever is remaining, you have made Principal and Interest payments on that BAN, there will be a net calculation what is outstanding on whatever day you close on long-term financing on this project, you would get that amount of money. So it was \$300,000, say we've paid \$100,000 randomly by the time they close, we will say our outstanding amount is \$200,000, you will get a wire transfer from the State for \$200,000 and will turn around and write a check to the bondholder that's holding the BAN for \$200,000 to pay them off. The BAN is now gone, it doesn't exist anymore, that cost because you've paid Principal payments and whatever that remaining amount of Principal was plus Interest for the part that you paid already, it would get rolled into this long-term financing. The one thing I have to check on is how many payments have we made. The State Finance Law allows you to make a certain number of payments and I'll check with Chris and she'll be able to say we made x payments and that will help us figure out when we need to make that long-term closing. We may need to make it in '17 and we can do that, there's a lot of different ways to do this, we just need to schedule it so that it fits. I think we took that on 2013.

**Supervisor Dellisanti** confirmed we made two payments on that loan.

**Mary Beth Bianconi** observed you made two, so you made '14 and '15 so then we're okay. I think you can make five so we should be okay, but we can figure this out. One of the things that we can do, we can actually close on long-term financing and continue to draw on the program

even if we aren't finished with the project if we needed to if for some reason. We've done that before. There's a certain amount of time you can keep these things open and then you have to make a decision, so we just make sure we coordinate all of that. And obviously our objective will be to eliminate or reduce as much of your interest payments as possible. Why pay interest when you can have it for free? So we'll coordinate all of that, that will be a down-the-road thing, but we'll make sure it's all reflected in this. I'll be back so you can ask me more questions later.

**Supervisor Dellisanti** asked any other questions? Let's go through with the resolution.

**RESOLUTION TO DECLARE LEAD AGENCY UNDER SEQRA ON MILL STREET  
PUMP STATION & WASTEWATER TREATMENT PLANT UPGRADES**

**WHEREAS** the Town of New Baltimore, Greene County, New York (hereinafter the "Town") has established the public benefit to the Town residents of upgrades to the Wastewater Treatment Plant (hereinafter the "WWTP") and the Mill Street Pump Station; and

**WHEREAS** the WWTP is in need of improvements to ensure the public safety and protect surface waters and the environment; and

**WHEREAS** the Town has conducted various studies of the condition of the system and the means for improvements; and

**WHEREAS** the Mill Street Pump Station was in need of improvements to ensure the public safety and protect surface waters and the environment; and

**WHEREAS** the Town passed a Resolution on August 26, 2013 authorizing the bidding for the renovation of the Mill Street Pump Station; and

**WHEREAS** the upgrade work on the Mill Street Pump Station has been completed as of June 9, 2014; and

**WHEREAS** the action of improving the Wastewater System is an Unlisted Action under the State Environmental Quality Review Act (SEQRA), but must be treated as a Type I Action due to requirements of the NYS Clean Water State Revolving Loan Fund; and

**WHEREAS** Part I of the Long Environmental Assessment Form (hereinafter "EAF") has been completed by the Town Engineering Consultant, Delaware Engineering,

**NOW, THEREFORE, BE IT RESOLVED** that the New Baltimore Town Board proposes to act as Lead Agency in the coordinated review of the Wastewater Improvement Project and shall distribute the attached Notice of Intent, Part I of the EAF, and project description and map to all potentially involved and interested agencies.

Thruway Authority 'Dear Supervisor Dellisanti: By letter dated November 16, 2015, the New York State Thruway Authority (Thruway Authority) reached out to potential involved agencies stating that it was considering lead agency status pursuant to the New York State Environmental Quality Review Act (SEQR) in connection with the review of an application submitted to the Thruway Authority from Pilgrim Transportation of New York, Inc. (Pilgrim) to construct, operate and maintain two pipelines from Linden, New Jersey to Albany, New York (Project). After careful consideration of the responses received from potential involved agencies, a review of Pilgrim's application to use and occupy New York State Thruway (Thruway) right-of-way, and a request from the New York State Department of Environmental Conservation (DEC) to serve as co-lead agency, the Thruway Authority, pursuant to this letter, is declaring itself as co-lead agency with the DEC for the Project.'

**Supervisor Dellisanti** explained with the resolution we had made before along with a number of other towns and villages in the state, it appears that we do have the DEC as co-lead agency on the project.

Letter from the Supervisor of Orchard Park 'Dear Supervisor Dellisanti: As you know we are trying to coordinate a grass roots effort to encourage the Governor and state officials to revisit the tax cap legislation in light of the fiscal difficulties it is generating for local communities throughout New York State.
