Received an email from Gary Fogelman on Monday, November 21, 2016 directed to Town Clerk Finke, 'I am emailing to notify you that the New York State Energy Research and Development Authority (NYSERDA) recently made several additions to the Local Law which will necessitate New Baltimore holding another public hearing in order to adopt the revised Local Law. Javier Barrios, cc'd here, may have contacted you some time ago regarding this matter. Attached is the revised CCA authorizing legislation. The Local Law now incorporates elements that can help your municipality earn energy grants through NYSERDA's brand new Clean Energy Communities program (CEC). I have attached additional information regarding the program. CCA Order Update: Regarding CCA Order proceedings, we are still waiting on the Public Service Commission (PSC) to comment on data costs and insurance requirements. At this point we cannot transact until the PSC completes this final phase of the CCA Order proceedings. We feel confident that this will be decided by the PSC soon so that we can begin acquiring energy data by first quarter of 2017.'

County Legislator

The top priorities during November continued to be the 2017 budget and the Greene County Jail project. The 2017 budget was adopted by a 9-5 vote at our regular meeting on Nov. 16, and will result in an 8.5% increase in County property tax rates. As I explained last month, next year's budget is a "status quo" budget, with the exception of a \$600,000 estimated interest payment for the jail bonding, if approved. Due to the potential bonding in 2017, we were very reluctant to use fund balance to reduce our increase in tax rate. Reduction in fund balance would negatively affect the rates available for bonding, and increase the interest rate for the next 30 years on the jail bond. Discussions and meetings on the budget revealed very little excessive spending, and turned more toward future budget procedures. A lot of our budget is mandated, a lot is State and Federal mandates that we have to provide services. Some of it we're reimbursed at 0%, some is at 25%, some is at 81%, others at 100%, but we have to make up the difference and we don't have a choice. State and Federal mandates consume approximately 85-90% of our County budget, leaving little room to reduce the services we control such as highways, veterans services, and the Sheriff road patrol. New mandates for 2017 nearly double the people qualified for public defense, which increases our expenditures by having to add staff. Public defender, district attorney, and judge salaries all increased due to state mandates. I voted for this budget because there were very few areas where real dollars were to be saved. Procedural discussions, as well as administrative structure, will continue into the new year in an attempt to restructure our budget process. Projecting forward, the 2018 and 2019 budget analysis is not promising. Simply put, we need mandate relief, we need to run more efficiently, and assessments need to increase by bringing business to Greene County. We did hold five years in the County under the tax cap and this is now coming home where you didn't spend the money before. It's now there where we just don't have it there out of fund balance to put toward a budget. The jail project continues to move forward. We met with the architect, project manager, and Delaware Engineering on a Saturday to discuss options and ensure that we have designed a facility that will meet our needs. We have identified approximately \$3 million in potential cost savings at this point. The PM has begun working on bid documents and we continue to discuss functions and programming options. We're in discussions with the State to see if they are willing to run a new water line to the Coxsackie Facility, who's having a problem right now with their water system, and share the cost which will significantly reduce the cost for us to bring that water line in. It will save us about \$600,000 if we can get them on board so we are working on that. The Deans Mill Rd. bridge has been replaced and is now open to all traffic. The new span has no limited weight capacity, and lanes are a little wider for passing traffic. The project was completed within the 6-8 week initial estimate with no surprises. I attended a ceremony to honor our 2016 Veteran of the Year, MSG Robert Whitbeck. Notable resolutions passed this month include: - Adoption of the 2017 budget, - Authorized a "Veteran Only" designated parking spot at the County Office Building in Catskill, - Authorized a contract through 2019 for solid waste transportation and removal, - Set public hearings for Senior exemption, Persons with Disabilities, and Agricultural District 124 for December 21, beginning at 6:15 pm.
