OPENING OF REGULAR MEETING

Supervisor Dellisanti opened the meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Deputy Supervisor Ruso, Councilmembers Briody, Irving and VanEtten, Town Clerk Finke, and 2 members of the public who signed the attendance book.

Absent: Tax Collector Jordan and Highway Superintendent Jordan

Supervisor Dellisanti: Thank you; first order of business is a brief presentation on our insurance from Nolan Pazin with Marshall & Sterling. Nolan, the floor is yours.

Nolan Pazin: Mr. Supervisor and members of the Town Board, before you I have had Marshall & Sterling make up proposals for a brief overview of your insurance for the year 2017-2018. There's no outstanding notices in that whatsoever, however, your property has increased by approximately \$74,813 and that basically is to cover the expenses that would be incurred for your property during the upcoming year. So you have a blanket policy so that's added to the blanket policy and as you can see your blanket total amount was \$1,870,311. This year it's gone up to \$1,945,124. So you had a slight increase in that, but that offsets for actually the cost of living for the building. As most of you realize last year, I had sent the policy out to our carriers for a quote. At that particular time they came back and Trident still was the best that we had as far as pricing goes and coverages go. So the Board decided that they would stay with Trident for another year and the reason we do that is about every three years we'll send it out to our markets that we have available through Marshall & Sterling. And the reason that we do it every three years instead of every year is it's just human nature that if something comes across your desk year after year after year after year and you don't obtain any type of positive approach as far as getting the account or even coming close to the account, it seems like we find that the underwriter doesn't bury it, but he doesn't give it his best foot forward. So we figure about every three years is a good barometer for us to do it. However, take into effect that if something was drastically to happen whether with the insurance carrier that you have today or if another market comes into place in the State of New York that I would not take a look at it and then meet with the Board or the Supervisor and say 'hey look at this is what's available, I would like to send it out to those various markets.' And also if you're unhappy with whether it be the claims or most of the times most of the Board is unhappy with the claims. So if you're unhappy with the claims and things don't seem to go right or the insurance company is paying claims that you feel that 'you know what, they should've never paid that,' well, that's for me to intervene in between the insurance company and you. With that, that's the reason we go out every three years. With that being said, if you take a look at your proposal for your insurance this year, you'll take notice, I believe it's on Page 3, gives you a highlight of your insurance coverages and what your premium was last year versus what your premium is going to be this year. If you quickly calculate it, it's around a 3 increase percent from over the last year. Jeff's giving me the eyes. Most of the insurance that I have this year has been about a 6 to a 9 percent increase. New Baltimore's right in that good line where it was only a 3 percent so I feel happy about it and I sat down with Nick earlier during the day and felt pretty comfortable with it. As I said your property went up \$74,000. So all in all Trident's been good. The claims, I don't believe there's a problem with any of the claims. You have a few claims, but Trident's been good with them, messaging them and trying to come up with a good solution instead of just writing a check and paying them. Are there any questions?

Supervisor Dellisanti: First I want to thank you for giving us the heads-up during the budget process. That was the best part because we actually budgeted \$32,000 for this year and we came in \$109 under budget. That's always a good thing to have done, but if it wasn't for you to give us the information ahead of time that wouldn't have happened. Also I'm glad you took the 2009 Chevy Impala off the insurance because that has been surplused so that won't be around. Other than that, I want to thank you for your due diligence, Nolan. You did a good job here.

Deputy Supervisor Ruso: I don't like 3 percent though.

Nolan Pazin: I figured that, Jeff.

Deputy Supervisor Ruso: As you well know the tax cap issues and so forth, this goes up 3 percent, that goes up whatever, they all go up. Everything goes up unfortunately.

If I was to take that and multiply it times the multiplication factor for property, it might be 1½ percent, 2 percent increase in your policy. It's nice for me to sit up here and then say that they gave it to you, but by the exact same token you're paying for it.
