## **OPENING OF REGULAR MEETING**

Supervisor Dellisanti opened the meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Deputy Supervisor Ruso, Councilmembers Irving and VanEtten, Tal Rappleyea, Esq., Town Clerk Finke, and 10 members of the public who signed the attendance book. Absent: Councilmember Briody (Business), Tax Collector Jordan, and Highway Superintendent Jordan

**Supervisor Dellisanti**: At this time I would like to introduce Erin Moore from Tighe & Bond who is going to do a presentation on our Hudson River Estuary Grant Program.

Erin Moore: I'm Erin Moore from Tighe & Bond. I wanted to just quickly introduce myself and my firm. I've been practicing in the Capital District and Hudson Valley since maybe 2005, but Tighe & Bond is a nearly 300-person firm that has been in New England, has opened their Red Hook office in the last year-and-a-half. So we are just south of here and very excited to be working in the Capital District and Hudson Valley. I've attached just information on us and some of the other things we do and if there is any time we could be helpful for the Town, we would love to provide any services. However, the grant opportunity that's available is from **NEIWPCC** and DEC and their main goal is understanding watershed connectivity and fish passage through different culverts for anyone who is in a watershed tributary to the Hudson River. What they have out for this is a 100% grant and there's actually three phases of the grant. The first is just an inventory of all the culverts in the Town that are in watersheds that are tributaries to the Hudson River. A culvert inventory is how large is the culvert, what material it's made out of, how far is it from the road surface down to the invert, if there's any drop from the culvert itself into the water body, and a field crew would go and measure all these things and produce a database that then would be presented to the Town and also on file with DEC. And we would prioritize culverts for if they're in good shape or not so good shape and that's pretty much the conclusion of that phase. Once the Town does that phase then they become open to other grant opportunities for making a plan to improve their culverts and then finally the third type of project is actually construction funding to replace problem culverts. It also takes into account culverts where you have flood problems. All three of these stages are 100% grants and they don't require the Town to be the contracted entity. So a for-profit enterprise such as a consulting engineer can be the grantee. And so we approached the Town to say 'we'll apply to NEIWPCC and DEC on your behalf' and certainly we'd want to collaborate with the Town and talk to Highway to see where the know problem culverts are. Essentially any culvert on private property, we would not be looking at any driveways, anything that's on private property would not be within the realm of the analysis; just public roads, taking the measurements. Certainly it's our insurance, not certainly any output by the Town, developing this data base and the conclusion would be the Town would have this data base of the culverts again what they're made of, what condition they're in, how big they are for future use either in pursuing additional grant opportunities or just for your own operation and maintenance procedure and figuring out what you've got and where you need to maintain. While DEC and NEIWPCC is really interested in if a fish or an eel can swim through the culvert, pretty much the data collected is really good for a lot of different purposes. What we need to proceed to be able to do this is a letter of support signed by the Supervisor just allowing us to be able to say 'yes, we are willing to pursue this grant or asking Tighe & Bond to pursue this grant with us as their teammate. Certainly if successful, we'll invite them back to talk to them about our culverts and let them go and do their analysis as it be.' So that's what we're requesting tonight. To give you an idea, currently DEC has prioritized four of your culverts. As you know there's many more than four in the Town so that gives you an idea. If you go to the DEC or Cornell website now, you can see what they say about these four. This is the current prioritized watershed map and you can see you're a lovely orange color which means we are a little higher up the chain than other communities. Red is a higher desire for prioritization meaning it's a more direct tributary to the Hudson River. So this half of the Town is not as much, but we think the most reasonable way is to approach it from a Town basis versus 'let's do this watershed and not, let's skip this one,' but certainly that's a nice color for hopefully prioritization. That's really the width and breadth of what I came to discuss. Again we're in Columbia County and currently working with Bethlehem, Kingston, Hyde Park, Fishkill, Millerton -- a whole bunch of different communities up and down the Hudson River. Can I answer any questions from the Board?

**Supervisor Dellisanti**: You and I spoke at length awhile back and I appreciate you coming tonight.

**Deputy Supervisor Ruso**: Tell me the difference between what could or should or what you plan on doing as when it comes to a Town-owned culvert or a state or a county (unable to understand).

**Erin Moore**: Anywhere that it's a road within the Town even if it's under their jurisdiction, we'll inventory it. Certainly when a decision comes to whether in the next stages we want to address how to address that culvert, we'll have to decide if we want to involve the county or the state in what they're willing to do or focus solely on the culverts we inventory within town borders. If you go to repair a culvert on a county road, the county certainly has jurisdiction. We're free to take the measurements and the material on the culvert, but from that point on then it's got to be a collaberative effort when there's cross jurisdiction like that.

**Deputy Supervisor Ruso**: So you plan on working with this grant as it relates to different entities not just the town on our town roads, but with the county and with the state.

**Erin Moore**: We'll cover every road jurisdiction within the Town, but if you decide to pursue a next phase where you actually talk about doing something with the culvert not just taking the data, then we really have to get a bit more collaborative on what's being approached here and how to do it.

**Ellie Alfeld**: I understand a grant to the Town means we don't pay any money for it. What do you get out of this?

**Erin Moore**: First of all we would do the work and we're as I said Tighe & Bond is a 300person firm and we've been in New England. We are so excited to be able to work with different communities. Again I've been working in the Hudson Valley, Capital District since 2005. I was with another firm before that and so I spent a lot of time here, but this is a great opportunity to get to know another community and be able to be a nice introduction to our services and the level of quality of engineering that we bring.

**Eilleen Vosburgh**: I was reading about this grant on EnCon and it said it's a total of \$200,000 will be made available for this RFP. Is that within all the communities that apply?

Erin Moore: Yes.

Eilleen Vosburgh: So it's not a lot.

**Erin Moore**: No, unfortunately we're talking about \$7,000-\$10,000. That's it. That's all we're talking about here. This is not a high ticket item. It's not \$200,000 or plus.

Eilleen Vosburgh: So that money will go to you.

Erin Moore: To us.

Eillen Vosburgh: For doing the work.

**Erin Moore**: And we've estimated it's about 30 minutes of culvert, everything goes into a GIS (Graphical Information System) database so not only will the system be in a data, maybe excel, it depends on whatever the Town wants to see it in, but it will also be in a GIS system and end up one of these points on the website where you can click on and see what the culvert is and who saw the culvert, and who inventoried it. One of the requirements of the analysis is there's a Northeast Coalition for Watershed Connectivity. So we have employees that are trained in that method of analyzing culverts and have been through that training and are certified North Atlantic Connectivity experts. I think we have some trout fishermen who would like to volunteer.

**Eilleen Vosburgh**: So I saw that there were three given last year in 2016 so pretty much you're trying to see which ones need the work the most but then all of the towns that you're doing right?

**Erin Moore**: We're working with four communities – Coeymans here, Esopus, and Fishkill. So a nice, interesting stretch down the Hudson River. We've worked with Fishkill before so this is a good opportunity to see if any value comes with this. Again this is sort of the entry level step. If you get through the inventory, then you're open to grant opportunities to doing more and certainly people have culvert stories for sure because flood impact is a part of this. While it's not the main goal, it weighs heavily when you get to the next step if there is flooding issues. Hyde Park has a 1500 foot long culvert that floods and goes under a firehouse and a leach field and we've said 'no, I don't think this is a good match for you.' Everyone has problems like that; hopefully they're shorter. It could be worse right.

**Tal Rappleyea, Esq.:** If you can identify specific species -- trout, eel, and whatever -- I think you could probably also get granting from Trout Unlimited. I've seen that in other towns; Chatham for instance has landed a grant from Trout Unlimited.

**Erin Moore**: Their focus was eel and it wasn't trout, it was something else. For some reason we've been very amused with the eels. Everyone's been very focused on the eel.

## Audience Member: And herring.

**Erin Moore**: It was eel and herring. That certainly builds upon it especially when it comes to construction phase because I know Trout Unlimited has done some construction phase funding and that's really the good stuff. Hopefully we're successful and then I'm back here in eight months telling you how the inventory went and looking forward to looking at prioritizing the culverts and moving forward on that.

Supervisor Dellisanti: Thank you Erin; thanks very much.
