OPENING OF REGULAR MEETING

Supervisor Ruso opened the meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Deputy Supervisor Dellisanti, Councilmembers Downes, Irving, and VanEtten, Deputy Town Clerk Jordan, and 3 members of the public who signed the attendance book.

County Legislator Pat Linger

County Legislator Linger: I apologize for the second sheet tonight and let me explain there was an additional item after the report was sent that happened. April was supposed to bring spring our way, and I think we're all still waiting for that. County highway crews continue to keep our roads clear, especially on the mountaintop where ice has fallen rather consistently when we've gotten rain in the valley. I did receive a call from a resident regarding flooding on one of our county roads and we are monitoring that going forward to develop a remediation plan if needed. Within 30 minutes of me notifying the highway superintendent, a supervisor was there to assess the situation. We held a special jail workshop that was supposed to gauge the extent of agreement on our design, but were again bogged down by a minority group, and no progress was made. We received an update from Mental Health regarding substance use/abuse in Greene County. The county is developing a reporting mechanism where first responders will be able to report Narcan usage immediately, giving us real-time data when assessing our use of resources. Data taken from NYS resources is 6-12 months old, and unreliable when moving resources to combat the problem in a specific area. The NYS budget included a reduction of 7% to community colleges. Through no action of our own, this will increase the budgetary responsibility of our property taxpayers since Greene County owns half of the college. I met with Barbara Lindsay, UGARC mobility manager, prior to the Transportation Advisory Board quarterly meeting. We would like to have the town post a link to the GCT website to increase awareness of our efforts to increase ridership and evolve our transportation plan going forward. And I can get that link to whoever does that. We received an update on the broadband maps from EDT&P. The county maps will be finished shortly and posted to the website. Residents will be able to see where the progress has been and will be made, search their own address, and contact providers. Our maps are more comprehensive than the NYS map, and are based on a more specific data set. The best use of them will be in conjunction with the state map. The state has maps available on their broadband website now. The development of our maps has been done entirely in house, and will give us a good data set to develop the "last mile" plan. The 17th annual GC Veteran of the Year ceremony will be held May 19, 2018 at 10 am on the Courthouse steps in Catskill. The GC Veterans Service agency is accepting nominations through May 3. Also on May 19th, the Cornell Hook & Ladder fire company will be hosting a Community Health and Safety Day from 10 am to 4 pm at the firehouse on Gill Rd. They have scheduled Narcan training, bystander CPR training, a Shed the Meds drug takeback booth, K-9 demonstrations, a residential sprinkler system demonstration, vial of life medical packets, fire extinguisher training, a junior firefighter obstacle course, and several county departments will be on hand with information for residents. There will be something there for everyone of any age. Please consider supporting our local first responders. While many of the approved resolutions for the month were contractual in nature, we did purchase a used bucket truck for use by Solid Waste. This equipment will help satisfy OSHA and PESH requirements when tarping waste trailers with a much safer method than in the past. We have been notified that the ARC bottle and can redemption in Catskill will be closing in May. This is a direct result of a loss of \$120,000 in NYS funding from this year's budget. The ARC hopes to convert the space into a small startup packaging business and employ many of the same disabled individuals. This month,

I presented a Wayne C. Speenburg grant to the Cornell Hook & Ladder fire company to assist with costs associated with their Community Health and Safety Day. The addendum that I sent subsequent to that, that was Friday afternoon at noontime. At 1:00 I got a call regarding this. Subsequent to my April report sent to the Town Clerk, a significant incident occurred at the GC Jail that needs to be reported. On Friday afternoon, April 20, an engineer from Kaaterskill Associates determined that an outside wall of the facility was potentially in danger of catastrophic failure. As an in-depth assessment could not be completed until this week, the decision was made to close the remaining housing units out of an abundance of caution for the safety of the staff and inmates occupying the building. The Sheriff with the support of the Legislature made this decision. A more detailed investigation is being done this week and a decision will be made as to any possible repairs. We received notice at approximately 1pm and a plan to house our inmates in Ulster County was initiated, as Columbia County could not take them all due to their facility population constraints. Permission from the NYS Commission of Corrections was obtained, and our facility was evacuated by 8pm. We expect to have a report by Thursday and will be making any repair or housing decisions following that report. It's expected that any stabilization efforts, if warranted, will take some time to accomplish and we will need to transport inmates to and from both Columbia and Ulster counties for the immediate future. At this time, we have approximately 30 inmates housed in Columbia, and approximately 20 in Ulster. Correction staff will be used to transport to court, doctor visits, processing new incarcerations from GC law enforcement agencies, and transporting them to jail. As a result, there may now be an opportunity for the inmate work crews to perform some maintenance around the county. This service had previously been halted due to staff shortages. If the Town has a project you would like to have done, please get in touch with Sheriff Seeley or Superintendent Spitz to discuss it. The operation of the jail is the responsibility of the Sheriff, but as always, my contact information is readily available for questions as well. And with that I can take any questions anybody's got.

Supervisor Ruso: What further updates since you wrote this?

County Legislator Linger: No, that Engineer was supposed to be in there today. I don't know how long it was going to take him to get inside the wall to find out how much damage there was. There's a concrete wall that the floors are tied into and then there's a façade on the outside. The façade is fine. The structural wall is where the damage is and that's damage that was noted to us last fall. It was suggested then because winter was impending to stop any further damage, we would pull the cap off the top, repoint the block, reseal the cap, and check it in the spring to try and mitigate any further damages occurring because what it was was a water leak that started it. So, he came in Friday and a gap that had been an inch last fall was now about two-and-half inches. He couldn't tell us exactly the condition of the wall, all he could say was if it goes it will be devastating. With that information it was a relatively easy decision on what we had to do, just wasn't something that we necessarily anticipated.

Supervisor Ruso: Was it in danger of collapsing inward?

County Legislator Linger: The inside wall is actually bowing out, what's not known is how those floors are tied into that wall. So the wall could collapse and the floors could be self-sustaining or the walls could collapse with the floors attached to them and the floors drop with the wall. That's what couldn't be diagnosed in that afternoon. So that's what they're supposed to be back in doing today to see what that is and if it's not as bad as it could be, is there a fix for it to where we could then bring people back in and not have them housed out in Ulster County.

Supervisor Ruso: How much does that cost?

County Legislator Linger: Right now Ulster County is giving us a rate of \$75 a day which is I think identical to Columbia County. We have to do all the transport, we're paying the medical. It is what it is. Their normal rate is much higher than that so they are giving us a break on it, but if it winds up being long-term, I don't think that \$75 rate would hold.

Ellie Alfeld: This water that is destroying for a better word this wall is it internal water leaks or is it outside?

County Legislator Linger: No, this is from outside coming in and what had happened was mortar on that cap block in the top had deteriorated so it was coming in between the two walls. Over time, however much time, I mean we're talking four floors up so it's not like it's something that you would see just walking by.

Ellie Alfeld: What is the cost to Greene County for the housing of an inmate? In other words have you ever figured out how much it costs or what we would charge if we were bringing in inmates from another county to us?

County Legislator Linger: That I don't know.

Ellie Alfeld: Just trying to see if it's about the same \$75 for us to keep this (unable to understand).

County Legislator Linger: No, it's actually a lot more than that. It's closer I want to say the last time we looked was just over \$200 a day, but that's because those are our employees that are doing it. When you house somewhere else, you're being housed in a bed that would otherwise be empty. So, they're recouping some of their loss in effect.

Ellie Alfeld: Unless another County needs space also and is willing to pay more than you are.

County Legislator Linger: It's possible and any of this is all subject to New York State Commission on Corrections approval. So we can't just say 'I'm gonna send four more over to Columbia or I'm gonna send three down to Ulster or two to Albany.' We have to get permission to do any of that. The State Commission on Corrections was very good on Friday; they understood that this was an emergency situation and the plans went very quickly.

Supervisor Ruso: Do you have enough vehicles to transport 50 inmates?

County Legislator Linger: Right now we believe we do and if not Ulster has said that they can loan us a van or two and we would just pay for the mileage on their van. It would be our folks doing the driving.

Ellie Alfeld: There goes the budget.

County Legislator Linger: There goes the budget. Again, we're a year-and-a-half into going back and forth on this whole issue and it is what it is. Not where any of us wanted to be I think and I don't know that this pushes anything forward either until this is hashed out.

Supervisor Ruso: Do I recall correctly that we seem to gain inmates during the warmer weather in the summer?

County Legislator Linger: Yes, I would say that even in looking fifteen years back, which I've done, I think your population is always a little bit higher as the weather warms up, but we've had the last two years our population has been fairly low in comparison to years past. Three month ago our daily average was in the mid-40's range, now we're in the mid-50's range. So, when we're in the middle of considering a new facility here and we're sitting at a population of 48 or 49 males. Right now, our new facility is slated to be 56 males. So, when people say this thing is we build too big or we design too big, you can't build according to a one-year population number. We have to build over a ten or fifteen year average number. So, we'll see where we wind up.

Councilmember Downes: So what's happening to the COs? Are they...

Supervisors Ruso: They're drivers now.

County Legislator Linger: The COs right now are going to be transports. So what we're going to do is generally your Courts whether it's towns, villages, or county will all operate between 9 AM and 9 PM so we'll have a 12 hour transport system going Monday through Friday, but at the same time we also need a 24 hour day, seven day a week intake. Let's say the Village of Coxsackie Police arrest somebody at 2 in the morning or if the State Police arrest somebody at 2 in the morning, they have to have someplace to go with that person after an arraignment. The plan is to have the other side of the jail that's not near this wall, that would be set up in one office for intake. They would be able to process there and from there our COs would be able to transport to either Columbia or Ulster or wherever is approved. The only thing we can't do is we won't be able to medically clear people because that takes three days and we don't have anyplace to house them right now for three days. That's another thing that had to be approved by Commission on Corrections and they're okay with that for now.

Councilmember Downes: No, I just meant we weren't cutting their time.

County Legislator Linger: We are not cutting anybody yet. There is no plan to cut anybody. We do still think that we can move our inmates back into our facility. A lot of that is going to depend on Thursday. But that's also why I mentioned that now rather than being short on staff, we will have some extra staff that can go down and pick up three or four inmates for the day and bring them out to paint a pavilion or paint the steps out here or whatever other little projects you have that need to be done. It may be a good opportunity for the Town to be able to take advantage of that.

Deputy Supervisor Dellisanti: Based on what Pat said, Mike Spitz if you can get him to schedule District 3 Park to scrape and paint the pavilion and the shed. I mean Shelly and I are trying to raise the money from the Friends to get you a new shed this summer so in between having it scraped and repaint everything is perfect.

County Legislator Linger: That's an opportunity that didn't exist before this because we were short-staffed.

Supervisor Ruso: We'll have to put our heads together to see if there's a particular project that would benefit the Town. I wouldn't mind a couple of other things. We do need a really good cleanup job at the Cornell Park before the regatta people get there on August 1. Things like that.

Councilmember Downes: Does there have to be any notice given to our town folks that they're coming in and they're going to be working District 3 or anything like that?

County Legislator Linger: I don't believe so. The only notice would have to go to Mike Spitz to put it on his schedule.

Deputy Supervisor Dellisanti: They're totally supervised when they did District 2 Park. They did a very good job.

Ellie Alfeld: And they did the front walkway and painted here some time ago, but they had to have a CO with them just to oversee them.

County Legislator Linger: And that's why it was held up for a little while a couple years anyway was because we were short-staffed. We have 37 correction officer positions that are approved from sergeant down and I believe we are employed at 28 right now. So, we just completed a test, they were planning to hire the rest, so we put that on hold for right now until we see what's going on with this. We're hoping it's not long-term, but we do expect that any repair that can be made is going to take some time. It's going to take at least a couple of months to get in there and stabilize the wall.

- 2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of town highways
 - a) On the road commencing at Dead End and leading to total distance of two and one-half miles, there shall be expended not over the sum of \$203,057.83
