Supervisor Ruso: The Town of New Baltimore donated to the Sprouts program as we have over the many years \$200. I think, unfortunately, this may end up being the last one because I've been informed by the Comptroller's Office that municipalities are not allowed to donate to not for profit causes. Actually they told me that that's been a law for quite a while and we've been doing this for I don't know how long.

Town Clerk Finke: Since before your time.

Councilmember VanEtten: Way before our time.

Supervisor Ruso: Oh, yes, well before our time. So, unfortunately, this will be the... We didn't get that word until after this was actually mailed out so we'll have to stop that for ongoing.

County Legislator Pat Linger

Before I get to the report in case Brianna doesn't want to stick around for the whole meeting, I also have a presentation for Brianna if you want to come up. So I have a commendation from the Legislature here for you and it's presented to 'Brianna Katherine Melick Whose Diligence and Persistence in Satisfying the Rigorous Requirements that Resulted in her Attainment of the Prestigious Rank of Gold Scout, Girl Scout Troup 1368 with Congratulations and Good Wishes of the People of Greene County" and it's from the Greene County Legislature and signed by our Chairman Kevin Lewis. So, thank you for putting in the work. Applause

Brianna Melick: Thank you.

County Legislator Linger: First, I would like to say that I hope everyone was able to take a few minutes today, Memorial Day, to remember those who made the ultimate sacrifice in defense of

our freedoms. I was able to attend the Memorial Day Ceremony at the Medway-Grapeville firehouse this morning held by the VFW. It was a somber reminder that freedom is never free, and many have paid a very high cost with their lives. I'll be brief with this month's report. In addition to our regular committee meetings, we had a report presented from Kaaterskill Engineering with their findings on the jail in Catskill. This leads us to get estimates for repair and a subsequent decision based on those estimates whether to repair or remain closed. We heard from 2 more departments this month relating to their budget and continue to schedule more workshops for this purpose. The first County Wide Shared Services Initiative meetings took place this month, with 2 more scheduled for June/July. Much like a broken record, I need to again mention discussions that have taken place with our jail. I voted in favor of the \$51.4 million bond resolution brought to the Public Safety Committee. That resolution passed in committee, however, was tabled by Finance Committee. At this point, in the interest of not wasting more time and money, we're discussing financing methods to reduce the bond amount. We hope to not completely lose the 2018 construction season. I was able to attend the GC Senior Day at the Point this month. It was well attended by over 250 seniors, and 2 were honored for their contributions to Greene County. I attended the Honor a Veteran Ceremony in Catskill last weekend where Al Doust of Coxsackie was this year's honoree. I attended the CH&L Fire and Safety Day where a plethora of information and demonstrations were available. It was a very good event despite the weather. Bids approved this month include highway materials, washed and crushed stone, and fuel oil. We authorized the purchase of a 4 wheel drive tractor and rotary mower, as well as a new 2016 Freightliner cab & chassis. The petition of notice and foreclosure has been posted on the county website. The treasurer believes this year will have an exceptionally low number of auctioned properties. The hazardous material cleanup day will be June 30, 2018 at the Athens highway garage. Stay tuned for more details. I have been in contact with both fire districts as well as town highway to see what projects can be done by our inmate workforce. I presented a Wayne C. Speenburg grant this month to the RC Sportsman Club Youth Fishing Derby. That event will be held on June 10th. I will be attending the 27th New Baltimore Agfest next weekend and hope to see everyone there! Greene County Public Health will be there with information on ticks and the various harmful effects of their rampant presence. Stop by and get educated to protect yourself and your loved ones. There was another notice that I got today by email there will be a community solar presentation from Cypress Creek. It's going to be June 14 from 5-8 PM at the Agriforestry Center on Route 23 in Acra. If anybody wants to take a look at that I believe they have four towns in the County right now, they have applications in. New Baltimore is not one of them I don't be believe, but it's a growing thing.

Deputy Supervisor Dellisanti: They're constructing these on Town property?

County Legislator Linger: No, all of these except one I believe are leased property. One is a land purchase that I'm aware of. We don't always hear about them until they come for a PILOT and that kind of got put on hold a little bit this month as well because there's so many out there. The PILOTS should really reflect the benefit to the communities that they're going in and not just because they're putting up renewable energy. I don't think it's the same to put up renewable energy and to sell it to Connecticut when they're being mounted here in Greene County. That's one of the things we're working on. Anything else?

Supervisor Ruso: No, thank you, Pat.

I attended the New York State Town Clerks Association Annual Conference from April 22-25 at the Desmond Hotel and Conference Center. The Conference began with a class on Sunday with Business Automation Services and included updates to their program. On Monday I attended the Opening Ceremony and Business Meeting where I was presented with my Registered Municipal Clerk Certification along with 13 other Town Clerks across the State. This certification requires 50 points in education and 50 points in experience. This meeting was followed by a General Session with the Association of Towns, Town Clerk Planning and Zoning Boards, and Understanding Solar. Tuesday began with the Electronic Death Reporting System which will be

operational in this area by the middle of 2019, Marriages, Using the MU1 Schedule, Rural Water, and our Annual Banquet. Our conference concluded on Wednesday with a presentation by Charles Marshall on the Service Method, Creating Success with Extraordinary Customer Service. There were two vendors -- KoFile Technologies and EZPass - in which I was most interested. KoFile Technologies preserves historical books, of which we have at least 13. Joe Degnan will be contacting me with a proposal, however, that may be in the distant future as we will be beginning General Code first. According to EZPass, it has been stated that tollbooths in New York State will be coming down in 2020. If residents do not have EZPass, a picture will be taken of their license plate and they will receive a bill for three times the amount of the toll. My office could offer to sell EZPass tags which are prepackaged and the resident contacts EZPass with their credit card or bank information to begin their account. The order must start with 20 units, could be divided with another Town, and they do not expire. With a tollbooth in our Town, I thought it is something we could do as a service to our residents. Interestingly, the Town currently does not have one. I received four FOILs in April and three were from the same person. The information is being compiled and the applicant has not paid the Town for the copies requested from their last FOILs in 2017. In consultation with our Attorney for the Town, one FOIL was not considered a FOIL and was directed to the Code Enforcement Officer and Clerk. I wanted to provide clarification from the last meeting. Superintendent Robert Libby from the Ravena-Coeymans-Selkirk Central School and Joanne Moran attended the May 9, 2016 Town Board Meeting and made a presentation with both Coxsackie-Athens and Greenville Central Schools. In 2015, Superintendent Alan McCartney confirmed for the May 11 Town Board Meeting, but tragically died from a heart attack on May 8.
