GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

- 1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
- 2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
- 3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
- 4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
- 5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
- 6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
- **7.** The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

NEW BUSINESS

Supervisor Ruso: We have our Budget Workshop Presentation for today. We have passed out our Tentative Budget for 2019 at the previous meeting for everyone to review and for any questions to come forth from any of the Board members or others who are so interested, but mostly to the Board Members. Are there any suggestions, comments, or questions about any of the items and line items identified on the document? I know I did receive a couple calls from yourselves and we resolved those questions. This is the Tentative Budget, the second budget that we put out will be the Preliminary Budget which will provide another opportunity for review, Public Hearing, and then we'll have the final budget. So, I'm going to make the Motion since there's no suggestions, that the Tentative Budget is as presented, I want to make a Motion that it's accepted by the Board seconded by Councilmember Downes. Any discussion? AYES: Ruso, Briody, Downes, Irving, VanEtten

Supervisor Ruso: I think I want to point out a few things for the budget. This year's budget does represent a very slight, but it's still a tax cut nevertheless, for the residents of the Town of New Baltimore and contrary to a lot of other jurisdictions around and about us, our tax rate has gone down. At the same time we have endured a few other things that one could be surprised by. We have managed to put in for all our hourly staff a 2% wage increase for 2019. That's what's proposed; it's in this budget. There are other factors that are of concern. The health insurance costs this year has risen by 13%; 13% is a hefty figure. There have been along the way in the past few years we have found some efficiencies along the way that have helped keep our tax rate down and we continue that same practice and pattern for 2019 and we've been able to maintain a relatively flat if not a slight decrease every year since 2014. Those are pretty much the highlights. I do think I need to point out some other factors here such as the salaries of our elected officials which I'll identify right now. For the Town Board personnel, yourselves, the four people sitting beside me, your annual salary has no change. It stays at \$4,100. Same as with myself, the Supervisor, my annual salary is at \$7,925. Our Court Justices, both of them, their salaries for 2018 will remain flat at \$10,610. Tax Collector will be at \$6,500, the Clerk will be at \$3,800 and I have one more and that's the Highway Superintendent.

Deputy Supervisor Dellisanti: Read that over again, the Clerk.

Supervisor Ruso: \$30,800. I had the Superintendent of Highways in here \$53,530 for 2019. So, that concludes our announcement of our elected officials and their annual salaries planned for 2019. Part of this conversation I want to go into is our Fiscal Stress report. Fiscal Stress Report figures were finalized at the end of September. They come out every year about the same time and they're put out by the Comptroller's Office. We have found continued improvement in our Fiscal Stress scores. Just to point out four long years ago we were at a 10. Best score is a 0 and we had 10. However, each year we've managed to bring it down some and last year we achieved a 3.3 on our Fiscal Stress scores and there's only one spot lower than that and that is a 0. And contrast to some of the other nearby communities who find they have scores in the 40's, 30's. We find ours is 3.3. So the Fiscal Stress scores from New Baltimore are excellent. The reasons why that are multiple. One of them has to do with our very low amount of debt, also the fact that we've managed to have a budget surplus year after year in contrast to a lot of other places that are running a deficit. Those are probably the two major factors as to why our stress figures have gone down. There are some things on the horizon that are of concern and some of them we can't do anything about. One of them has to do with some decreases in our population which seem to be on the horizon and areawide the age of our population is also a factor which we don't have anything to say; the Board certainly doesn't. So, our Stress Report is good news, we are holding steady at 3.3 for the second year in a row.

Deputy Supervisor Dellisanti: I just want to make a comment on your Tentative Budget for a second. Just so everyone knows, this is the fifth year in a row that the Town Board has presented a budget decrease for the residents of New Baltimore and I compliment you all on that.

Supervisor Ruso: I actually need to compliment two people who've been very helpful in helping me to get this budget prepared. Specifically new to our group is Kelly who's expertise is well-appreciated, particularly your computer expertise I must say and the other expertise who is a hand at this, he knows his way around it and that is our Deputy Supervisor Nick Dellisanti who's background and knowledge in this is so helpful. It would have been much more laborious and heavier tasks without his help. So, thank you both by the way every much. This budget that we've accepted, this Tentative Budget, is now going to have all the figures moved over to the box that says Preliminary Budget if you can see that on your document. So, these figures are going to be moved over and this will be your Preliminary Budget. So we're going to have a resolution to set a hearing for our Preliminary Budget and I would like to have that two weeks from tonight on October 22.

We will vote upon accepting this policy at the next Board Meeting on October 22. Once we have that, then we'll introduce it to all the town employees and have them appropriately in-serviced. Aside from that, there is another conversation we're going to have on the 22nd. Whitney Pangburn from Marshall & Sterling will be here and going to present to us our employee health care package for 2019. The one that affects the Town employees, it begins on December 1 of 2018. So she's also going to be here on the 22nd.

Emergency Management Officer VanWormer: Tuesday, the 16th will be the Workplace Violence Training here at 9:30. Joe Cook from the Department of Labor will be coming down to do it. They will do it for us the first time. After that they give us the guidelines and we do it ourselves after that. The Sexual Harassment part, Pat Linger is supposed to get me the contact information for the lady in the County that does it for the County. I don't think the Department of Labor will not do Sexual Harassment because it doesn't fall within their jurisdiction so they don't do the training.

Supervisor Ruso: We'll take what we can get.

Councilmember VanEtten: So all the Boards have to do it. So what about the people that work full time?

Emergency Management Officer VanWormer: I can probably get him back here. After Tuesday, I'll be able to do it myself so I can do it myself.

Councilmember Downes: Can I give you certificate?

Emergency Management Officer VanWormer: Sure.

Supervisor Ruso: You already have it?

Councilmember Downes: I have to do it every year. I'll just get a certificate. Anything else you need, Workplace Violence?

Emergency Management Officer VanWormer: You have to have Sexual Harassment and Joe Cook is also going to teach Right to Know.

Councilmember Downes: So I'll just run all my certificates and just give them to you, that works?

Town Clerk Finke: I will put into your file.
