GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

- 1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
- 2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
- 3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
- 4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
- 5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
- 6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
- 7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

Supervisor Ruso: I have my report and mostly it's about our March financials. I hope you folks have had the opportunity to read them. Any changes? I'll make a Motion to accept the March financials.

Supervisor Ruso: I got an email from Alan VanWormer and it's about the required Sexual Harassment and Workplace Violence training. Alan has found an online program, it takes 45 minutes per session, employees can take it at their leisure from any computer and print a completion certificate when finished. He's also looking to find a way to do it in a group session which I guess we could. So we can do that. So we can set it up here at a meeting or one night after the meeting or something to that affect.

Alan VanWormer: As long as we have email addresses and names for everybody so they can log in, enter the thing, you just click on your name and print your certificate.

Supervisor Ruso: So I think what's left for the Board to do is because there's a lot of people who are behind. COVID put everybody behind and all this stuff is geared up to go again and so we need to set a deadline for the training to be completed for all Town employees including ourselves, other Boards etc., etc., etc., Judges that just left. Do we have any ideas in terms of a deadline that we want to assert for all employees?

Councilmember Boehlke: Probably before school vacations start.

Supervisor Ruso: Well, I'm thinking the end of June because May's just around the corner. That's too quick. So I'm thinking give them nine weeks basically.

Councilmember VanEtten: And you can do this at home also, Alan? You can do it you're our own computers.

Alan VanWormer: Yup. Yup. What I'll do is I'll put in your name and your email address. It will send you an invitation, you click on it, it walks you right through it from there.

Supervisor Ruso: I have to pass a message out to the Zoning Board, Planning Board. You can certainly tell the Highway people and the list goes on. I'm just throwing it out there the end of June, does anyone have a different date in mind?

Councilmember VanEtten: Forty-five minutes, I think we can do that by the end of June.

Supervisor Ruso: Thank you for finding that out for us.

County Legislator Linger

As you may have noticed, I have been uncharacteristically absent from Town Board meetings since January's Organizational Meeting. On January 4, I was taken from work to the hospital by ambulance, and was diagnosed with a dissecting aorta. Surgeons gave me a 20 - 30 percent chance of surviving the surgery, as the dissection was about 80% complete when diagnosed. Blood flow considerations following surgery required a carotid bypass and a subclavian bypass. An allergic reaction to a blood thinner resulted in a stroke, and we threw in a positive Covid diagnosis for good measure. Through the miracles of modern medicine and a lot of people in my corner, I'm here giving my report tonight. I have returned to work and have one visit left at both Physical and Occupational Therapy to complete that. We have begun a new composting pilot program at the Catskill Transfer Station. We purchased a 1,000 pound per day machine to test and gauge interest. If successful, we will purchase a larger machine in the future and move this one to the mountaintop. Indications are that a successful composting venture could divert up to 30% of our solid waste from the landfill. Sticking with solid waste, we have put aside over \$4.2 million to use for redoing both the Catskill and Coxsackie transfer stations. Construction has begun in Coxsackie and all C&D waste must be taken to Catskill temporarily. We approved the household hazardous waste collection for 2 dates this year. I don't have the dates yet, but one will be this summer in Athens and a second will be in the fall on the mountain. We approved public comments opposing the Draft Scoping Plan of the Climate Leadership and Community Protection Act to be sent to the NYS Climate Action Council. The plan unfairly puts the majority of compliance burdens on Upstate NY residents. Public comments are being accepted until June 10, 2022. Medication assisted treatments such as suboxone and others are now mandated in county jails. Greene County will receive \$101,250 from OASAS to fund this. We approved fuel bids from Bottini Fuel for next year at 12 cents over tank car price for County buildings, and 13.5 cents over for all other municipalities. We approved LTRW out of Albany to perform the architectural design of the new Justice Center and courthouse addition. We hope to put this project out to bid by the end of the year. We approved leasing space in the Cairo office building for a new Veteran Reintegration Center. The \$92,500 cost of operating center will be funded through a Joseph P. Dwyer peer-to-peer program grant. We approved engineering costs of \$335,000 for the CR 61 bridge over the Coxsackie Creek. That replacement is expected to take place in 2023. We will hold a public hearing on a proposed Solar PILOT Law on Wednesday, May 4 at 6pm. This local law will set the rate for all commercial/industrial PILOTs at \$8,750 per megawatt. NYSERDA has stopped providing PILOT guidelines, prompting this change. We appointed Edward Brandt Coroner to replace Paul Seney, who resigned. The GCSO put into service therapy dog Mac, who is based in the Cairo with his handler Deputy Espel. I will present a Wayne C. Speenburg grant to the Agfest committee to help offset costs after a 2-year hiatus.

Town Clerk Finke: Welcome back, Pat. We missed you, we really did.

Supervisor Ruso: I have three questions for you. The Bottini fuel, is that no. 2 fuel oil, is it diesel? What is that?

County Legislator Linger: It's heating oil.

Supervisor Ruso: We've been getting it from them. The second question is has your PILOT law that you're proposing, has it been published yet? Is it available for a review?

County Legislator Linger: I have to look and see if it hit the website yet.

Supervisor Ruso: Because I would really like to see it before I make my comment.

County Legislator Linger: No, we just approved it Wednesday night so I'm pretty sure it hit the website already, but I'd have to look.

Supervisor Ruso: And the last question is kind of out of the blue...

County Legislator Linger: And that is it's gonna be effective for the County PILOT so if the Town and the School District want to do their own, they'll have to do their own local law.

Supervisor Ruso: That's not 100 percent consistent with my conversation with Ray Ward. He was talking about \$8,500 and it comes out to be \$8,750, but he was just talking rough and that would be the total for all municipal organizations to share was \$8,500.

County Legislator Linger: Correct.

Supervisor Ruso: And we would get a piece of it.

County Legislator Linger: Does the Town not have to pass the same resolution, though, to do

that?

Supervisor Ruso: We have some input into this, yes. So in fact some of these conversations are gonna be part of our Solar Committee because the PILOT as I was informed we have all the risk, the Town of New Baltimore and the other Towns do, and we get 12 percent of every PILOT. So we would get 12 percent of \$8,750.

Council Legislator Linger: Well, that's per megawatt.

Supervisor Ruso: Per megawatt, yes. Some of the lots that they're on, we currently get more taxes from them than we would get from the PILOT. So we would have a problem approving that obviously.

County Legislator Linger: NYSERDA used to say three percent was the average that they would do for PILOTS. They've now have taken all of their recommendations away so there are no recommendations now and typically what they're doing is under-valuating the solar projects.

Supervisor Ruso: Teichos and the others are really looking to lowball it.

County Legislator Linger: Yeah, so this puts it at I believe it's a 3 1/2 percent PILOT roughly and it's a given, here's what it is, it's \$8,750 per megawatt.

Supervisor Ruso: I like the idea of it, sometimes the devil is in the details. The last question, I don't recall and Alan didn't recall, do they take tires in Coxsackie Transfer Station?

County Legislator Linger: I believe so.

Councilmember Boehlke: They do online.

County Legislator Linger: They have been.

Councilmember Boehlke: It's online that they take them.

Councilmember Downes: He looked it up and it said...

County Legislator Linger: I can find out if that's changed because of construction that's going on, but I don't believe so.

Supervisor Ruso: Well, W&W has been taking our tires forever and they are no longer going to accept tires.

Highway Superintendent VanWormer: I called Catskill to see if we could set up an account with them and they don't do accounts (unable to understand) credit card or cash so when I called Scott, and he said to bring them to the Catskill Transfer Station.

County Legislator Linger: To Catskill? I wonder if that's just because of the construction that's going on in Coxsackie.

Highway Superintendent VanWormer: It could be, yes.

County Legislator Linger: The only thing I was aware of was construction and demolition that couldn't go to Coxsackie, but it could be tires as well.

Supervisor Ruso: Some of the points obviously if we're bringing them to W&W, not even a mile away or going to Catskill, there's a higher cost to the Town of doing that and we end up pretty much collecting \$3 and we're paying \$3. Now we're collecting \$3 and it's costing us more and that doesn't even count the tires that you find on the road. Not the most costly thing, but we were looking at that. If you could find out if we could take them to Coxsackie, that would be a lot easier.

Highway Superintendent VanWormer: I'll call Scott.

Ellie Alfeld: Patrick, you said C&D is not gonna be at Coxsackie correct?

County Legislator Linger: Not while they're doing construction.

Ellie Alfeld: But I can bring my household stuff?

Historian Ted Hilscher I have been invited by our friends at the Ravena-Coeymans-Selkirk Community Library to supply the images for the community display area of the library lobby for the months of May and June. I have chosen 12 historic black and white photographs from New Baltimore history, 6 of the hamlet and 6 outside the hamlet, and written a short brochure to provide text for each image. The hamlet photos cover the ice and ship building industries, and prominent buildings no longer standing such as stores and hotels. For "outside the hamlet" I chose six images of farm life on the Lisk/Hallock Farm on Roberts Hill Road. The former Albertus Hotaling house on Reservoir Road was featured as a classic example of rural nineteenth century Greek Revival architecture. Town Clerk Finke: Both of the bids came in today at 3:45 PM.

Callanan Industries Estimated Total: 5,385 Tons Unit Price: \$72.45/Ton **Peckham Road Corp.** Total Bid Price: \$485,798.90

Supervisor Ruso: I can see a couple things on this. Peckham has a total price identified for the

roads.

Councilmember VanEtten: You have to multiply this by this.

Councilmember Downes: It's \$390,143.25.

Councilmember VanEtten: That's the total for Callanan?

Councilmember Downes: That's what I'm coming up with, anybody come up with anything

different?

Supervisor Ruso: Let me just check one more piece of math here because the number of tons identified I would like to verify this with Alan. Let's see now 3,924 tons that's for Deans Mills, 1,950 for Flatbush, plus 54 for Taylor that little thing, plus 127, that's 6,055 tons. My question to you, Mr. VanWormer, is why does Peckham say they're gonna charge us 6,055 tons whereas Callanan suggested it will be 5,385 tons?

Highway Superintendent VanWormer: That I don't know. They both came and looked at them, I'm not really sure why there a difference in tonnage.

Supervisor Ruso: Well, the cost per ton for Callanan's is \$72.45, the price per ton, and he has three different figures here believe it or not and I don't know why.

Highway Superintendent VanWormer: Yeah, I'm confused on that.

Supervisor Ruso: The lowest price he has for the tonnage on Deans Mill is \$78.35, the next lowest is \$79.50 for Flatbush, and then he wants \$110 for Taylor Road, and \$125 for Hadley Road.

Councilmember Downes: It drops every time your tonnage goes up.

Supervisor Ruso: So really the price per ton for Callanan is approximately \$6 less, actually \$5.90 less than Peckham's, and furthermore the total cost at their estimates is \$390,143 versus the cost at Peckham's of \$485,798. So it's a difference of \$95,000. So obviously I'm gonna suggest that unless there's some other information to bear upon this decision. I think that the Callanan bid is the winning bid. Now we'll vote on that, but I wanted your input before we voted, sir.

Highway Superintendent VanWormer: That's fine with Callahan, too.

Supervisor Ruso: So I guess I'll make a Motion to accept the bid for Callanan for paving for this year's road repairs. So I'll make that Motion.

Councilmember VanEtten: I'll second.

Deputy Supervisor Dellisanti: The budget for the CHIPS money was like \$381,000?

Highway Superintendent VanWormer: Yeah, we're gonna have to cut back. I might not be able to do Hadley. I might have to take that back off.

Deputy Supervisor Dellisanti: You're gonna have to redo the 284 Agreement.

Highway Superintendent VanWormer: Yeah, we'll have to revise it.

Highway Superintendent VanWormer: Oh, no. Whatever we use, that's what they're gonna do

Councilmember Boehlke: There's a lot less responsibility on our part, too, with Callanan's. They have a whole list of notations with Peckham including what's this fuel price adjustment, asphalt and fuel price adjustment? So they've got some built in.

Supervisor Ruso: So they have some add-ons.

Highway Superintendent VanWormer: They just call it index.

Councilmember Boehlke: What is that do you know?

Highway Superintendent VanWormer: I guess it's the fluctuation day to day on what oil

prices do,

Councilmember Boehlke: So they can adjust this within the agreement.

You don't need a CDL license to operate equipment, but you do need one to drive truck.
